

COOKIE POLICY

Our Platforms (“**Platforms**” means the website(s), including but not limited to <http://retarg.com/> and related websites and/or subdomains (the “**Site**”) and any related documentation, services; any images, logos, photographs and video content, software, designs, graphics, photos, illustrations, animations, videos, scripts, texts, music, sounds, voiceover, interactive features, and all other materials and content accessible within the Site that are incorporated into and form part of our Site and etc. (“**Site Content**”)) are operated by the Company as specified in our Privacy Policy.

WHAT ARE COOKIES?

Cookies are tiny text files stored in your web browser. They help us or third parties recognize you. These files save and retrieve identifiers and other important details on computers, phones, and other devices. Cookies can collect, store, and share bits of information, like IP addresses, about what you do online, including on our Platforms.

WHY DO WE USE COOKIES?

We use cookies to enhance your experience on our Site and improve its functionality. While cookies aren't absolutely necessary, they make using our Site much easier. They do a few different things:

- remember things you've chosen, like if you want to see a certain message or how many times you want to see it;
- keep track of what you do on the Site so it can work better for you;
- gather general information without identifying individuals to help make the Site work better overall.

When using our Platforms, we ask for your consent to the use of cookies (as defined) in accordance with the Privacy Policy. The consent provided is voluntary and can be withdrawn at any time.

TYPES OF COOKIES WE USE

We make use of both session cookies and persistent cookies on our Platforms:

Session cookies: these are used to identify a specific visit to our Platforms and expire after a short period or when you close your web browser. They help recognize you during a single browsing session and are automatically deleted when you close your browser.

Persistent cookies: these remain on your devices for a predetermined period, even after you close your browser, e.g., we employ persistent cookies to keep you logged in to our Platforms.

WHAT KINDS OF COOKIES ARE ON OUR PLATFORMS?

Here's a general description of the specific types of first and third-party cookies used on our Platforms and their respective purposes:

Strictly necessary cookies:

- essential for the Platforms to operate and cannot be disabled in our systems;
- typically activated in response to actions you take, such as setting privacy preferences, logging in, or completing forms;
- while you can configure your browser to block or notify you about these cookies, certain parts of the Platforms may not function properly if these cookies are disabled;
- do not store any personally identifiable information.

Functional cookies:

- enhance the functionality and personalization of the Platforms;
- may be set by us or third-party providers whose services we integrate into our Platforms;
- disabling them may result in some or all of these services not working correctly.

Analytical and performance cookies:

- enable us to track visits and traffic sources to measure and enhance the performance of our Platforms;
- may be set by us or third-party vendors to help us identify the most and least popular pages and understand how users navigate the Platforms;
- all data collected by these cookies is aggregated and anonymous;
- if you opt out of these cookies, we will not be able to track your visits to our Platforms or monitor your performance.

Advertising and targeting cookies:

- may be set by our Platforms' advertising partners;
- enable our advertising partners to create a profile of your interests and display relevant advertisements on other websites;
- while these cookies do not store personal data directly, they use unique identifiers to identify your browser and internet device;
- disabling these cookies may result in less personalized advertising being displayed to you.
